| <u>Executive Director Report</u> | <p>The Executive Director Patricia D’Antonio and Board of Pharmacy Chair Dr. Bernard represented the District at the NABP 110th Annual Meeting held at the Sheraton Phoenix Downtown Hotel in Phoenix, AZ, from May 17-20, 2014</p> <p>The NABP 110th Annual Meeting provides pharmacy board members and staff as well as other pharmacy stakeholders with an opportunity to take an active role in protecting the public health. The gathering also serves as the venue for boards of pharmacy to elect members of the NABP Executive Committee, to review and vote on NABP policies, and to guide the direction of the Association.</p> <p>The NABP meeting was centered on the eight adopted resolutions which centered on:</p> <ul style="list-style-type: none">• Collaborating with Federal and State agencies regarding policies surrounding the illegal importation of prescription drugs;• Convening a task force to examine strategies for preventing and reacting to pharmacy robberies and thefts.• Reaffirming NABP existing policy that encourages regular pharmacies to stop the sale of tobacco products and work towards a smoke- free society.• Convening a task force to develop standards to ensure regular, consistent, and appropriate use of prescription monitoring program(PMP) data as well as facilitating cooperation between state PMP’s, NABP PMP InterConnect, other health care entities, and state health data exchanges• Encouraging the development and availability of veterinary pharmacology education to ensure the competence of pharmacists dispensing medication for veterinary patients; and• Support Food and Drug Administration and appropriate state agencies regarding the regulation of electronic cigarettes and liquid nicotine products <p>Executive Director D’Antonio also emphasized on the significant discussion on Drug Quality and Security Act (DQSA) Federal Law passed that addresses outsourcing pharmacy with regards to compounding and also the Distribution of drugs (“track and trace”). | <p>o605-O-01</p> | <p>Legislative and Regulatory Subcommittee Report</p> <p>(a) Collaborative Practice: A report from Mr. Alan Friedman shed light on the meeting held on May 8th by the sub-committee made up of representatives from Board of Pharmacy, Board of Medicine and the Department of Health. The group is currently drafting regulations for collaborative practice. The intent is to then have the proposed draft to the respective Boards for consideration and approval and then shared with the public for comments. Mr. Friedman stated that the meeting went well.</p> <p>(b) Pharmacy Technician Legislation: In respect to Pharmacy Technician Legislation, Mr. Friedman stated that the proposed regulations were handed out at the public session of the May 1st Board of Pharmacy meeting with comments requested as previously discussed at the Board meetings. The Board of Pharmacy offered to solicit comments from stake holders and informal comments for the proposed regulation. Mr. Friedman noted that the Legislative and Regulatory committee deemed it necessary to invite these comments to prevent and minimize substantial changes made to the proposed regulation upon approval by the Board and publication to the DC Register for official formal comments. If substantial changes are made based on comments received after publication to the DC Register, the regulations may need to be republished in the register. Notices were sent via e-mail on May 5th to all registered pharmacist with valid e-mail addresses for the District of Columbia as well as key contacts both local and national regarding comments. E-mail sent referenced the Board’s intent to receive written comments and conduct a listening session during an informal comment period between May 5th and the present day of the Board meeting. According to Mr. Friedman, comments could be prepared and shared in two ways. First, it must have been sent and received by the Board no later than Friday May 23rd or notification must have been received by Ms. Karin Barron no later than last Friday May30th 2014. If an individual’s intent was to share his or her comments in the listening session at the June 5th Board meeting, ten copies of their presentation material were to be made available if material is different from what was submitted on May 23rd. The Board received two comments from Foer’s Pharmacy and the DC Hospital Association. Mr. Friedman concluded by stating that the legislative and Regulatory committee will meet on June 9th and the comments received will be put into consideration. The Legislative and Regulatory committee intends to consider changes prior to the next session which is August 7th and come prepared to propose regulations to go through legal sufficiency and be published in the DC Register for 30 day comment period.</p> | |
